

## PRICE LIST

The price list of services offered as part of the operating lease of vehicles (the "Price List") sets out the price terms of services offered by LeasePlan Slovakia, s.r.o. in addition to those provided for in the Framework Agreement and serves as amendment thereto and to the General Terms and Conditions of Operating Lease.

### C. Vehicle Transport and Parking Area

Terms of Vehicle Transport Service (including tow-away):

- The service is provided for motor vehicles up to 3.5t maximum authorised mass only
- A mobile vehicle will be picked up for transport to a parking area of LeasePlan (so-called transport on its own wheels) within five (5) working days from transport request
- The price of transporting a vehicle to the parking area in EUR/km shall be determined using the distance between the location of the transported vehicle and the parking area of LeasePlan, Slovakia Auto, s.r.o., Panónska 30, Bratislava
- When transporting a mobile vehicle, the consumed fuel shall be paid by the Lessee
- The service provider shall not be liable for any staining of the vehicle exterior due to weather conditions
